The Court accepts the complaint and will investigate the agents for the CBD case

The Batllia accepted the complaint filed by Mercedes Chamorro, mother of the defendant in the CBD case, in which her son is being tried for alleged crimes related to drug trafficking, according to EL PERIÒDIC. The complaint, filed last October 22nd, accuses two members of the Principality's police force of an alleged omission of the duty to prosecute crimes, in accordance with article 405 of the Criminal Code.

As detailed in the order issued by the judge Eduard Canut, the document emphasizes the need to investigate the facts presented by the complainant. The decision of the Court will allow the instruction of preliminary proceedings to determine the nature of the facts and the potential responsibilities of the policemen who would allegedly be involved. As part of this process, the Public Prosecutor's Office is notified, and all the corresponding actions will be recorded in order to collect the necessary evidence and proceed with the necessary interrogations.

This judicial move occurs while the expectation remains about the resolution of the trial of the CBD case, which was held on October 23rd and 25th. In these sessions, the defense appealed to the application of the error of invincible prohibition - given the circumstan-

ces of ignorance of the crime on the part of its defendant -, and for its part, the Prosecutor's Office presented the accusation and reason for conviction due to the «large quantity of the confiscated product» that the defendant, who has been imprisoned for more than a year, was carrying. The final decision, which will determine the young man's guilt or innocence, is scheduled for next November 20th.

The complaint filed by Chamorro was motivated by her suspicions of irregularities in the police investigation process that would have led to the arrest of her son. As stated in the official judicial document, the Court considers that there are sufficient elements to proceed with a formal investigation into the «possible negligence of the police» in the exercise of their duty to prosecute crimes. ●
