The Pas variant and a segregated road to La Seu, priority connections

The Government rules out railway projects with Catalonia and France because they are expensive and have an excessive impact

Spain is open to expanding the N-145 with a third reversible lane to improve capacity

ast Wednesday, the Government revealed the priorities of the Ministries of Economy and Territory in terms of connections with the outside world. Ministers Jordi Gallardo and Víctor Filloy, accompanied by the director of Mobility, Jaume Bonell, presented the Study of the possibilities of opening the Andorran mobility network, in which the most viable projects and those presenting the most difficulties are glimpsed. The Pas de la Casa variant, the Caubella heliport and the connection via segregated transport to the airport and La Seu d'Urgell are the three projects with the most options to see the light of day in the future, as they depend on good part of the will of the Andorran authorities.

Pas de la Casa variant through the Solana road stands out, with a cost estimate of 59 million euros. The new road, which would connect Andorra with France, from the Pas to Ospitalet, would be 6.4 kilometers long, with a kilometer of viaducts and an avalanche gallery. Most of the road would pass through Andorran territory and would save time, with about four kilometers less. It would only require the agreement with France, because a new customs house would have to be built, since the current one is on the other section of the French N-20. The Caubella heliport, the second project with the most options, would be located entirely in Andorran territory and would mean the introduction of new forms of aeronautical connections, apart from the traditional helicopter, which would enable the arrival of tourists from beyond the traditional markets, one of the objectives of the ope-

ning of the country's mobility network.

Thirdly, Mobility foresees a segregated transport that would connect Andorra, from La Farga de Moles, along the right side of the river to La Seu d'Urgell and the airport, through a regular collective electric road (REC), with an estimated cost of 130 million euros. It would be an exclusive and direct route to Andorra without going through customs, intended mainly for airport passengers. The platform, which could be used by several types of electric vehicles, could transport between 500 and 1,500 people per hour in both directions. As for the less viable options proposed by the study, they refer to rail connections with France and Catalonia, a possibility that, for the time being, the Government rules out as being too expensive and because it would have a significant environmental impact. «We have not



we carry out what depends on us». In the preparation of this study, Mobility has met with the General Directorate of Traffic (DGT) and the Spanish Ministry of Mobility, where the state of the N-260 and N-145 has been addressed. Regarding this, Bonell revealed that in the first case there is already a planned investment of 43 million euros, between Adrall and La Seu d'Urgell. In the second case, there is a commitment to analyze a capacity expansion project, with a third reversible lane. In fact, currently, on the Andorran side, leaving the country, the road can absorb 1,000 vehicles an hour, while on the N-145, entering Andorra, only 750. «This causes an accordion effect with delays to leave Andorra and complicates road safety due to the traffic flows that arrive suddenly at La Seu d'Urgell, so the double lane could reverse it depending on the intensities», explained the director of Mobility. \equiv

he president of the Social Democratic Parliamentary Group, Pere López, criticized last Wednesday in a press conference the decision of the majority to finally not increase the salaries of high political positions in accordance with the CPI in 2023, calling it an electioneering gesture. «I'm really very surprised, because it's been a few years since I've been a parliamentarian and I've been a minister, and I've never seen an action, with all due respect, as ridiculous and as inappropriate for political activity as this,» he lamented. During the debate on the full amendment to the budget «we already said that this could not be done in any way», assured López, who at the same time explained that the wording of the law is already done, and «if you don't like it, the task of parliamentary groups is to amend, debate, discuss things; not make a press release», since, if the text is not modified, «What does this resignation mean? How will you control what needs to be done?», he questioned.

So, claiming that the majority does not intend to amend the article, López assured that «we will.»

Therefore, the PS will present an amendment so that these charges have the same increase as the private sector. According to his proposal, the increase would be 7% in terms of the minimum wage, and there would be a step between 6.5% and 0.5% up to 4,000 euros, a fraction that would no longer be affected. In this sense, the president of the parliamentary group announced that he personally would not receive any increase, «but not because he makes any resignation, any gesture towards the gallery or anything that is inappropriate for parliamentarians, but in the case that accept the amendment that we will present», he clarified. As for the social democratic counci-



ding why the Government entered the bill, López assured that it will not be withdrawn and, in fact, «with all these improvised movements there is still much more reason for this question to be formulated and answered», he pointed out.

For her part, the non-affiliated councilor general, Carine Montaner, recalled that during the session of the General Council on September 13th, she proposed a reduction in the salaries of politicians and senior positions in the Public Administration. Regarding this demand, Montaner observed that the head of government «hinted that the proposal was populist and would not solve the problem of public finances by any means». This measure has finally been taken, and for this reason, she regretted that the Executive «immediately attacks other political colors considered as adversaries, instead of reflecting on the substance of the proposal». Finally, she emphasized that «political maturity is needed in this legislature».≡
