FEDA expects to close the year 2022 with losses of 20 million euros

Moles admits that the possibility of power cuts is «real» and a contingency plan is being drawn up The company rules out a new price increase, although it will depend on international developments

EDA expects to close the year 2022 with a deficit of 20 million euros, although 15 million are part of the capitalization to the Government, so the global calculation will be around -5 million, depending on the final treasury tensions. Although this is a negative result, the situation could be even worse if in the last decade «the decisions that were taken and that have allowed us for many years to have a healthy company, with large reserves, had not been taken in the box, which have helped us overcome the first stage» of the current energy crisis. This was stated last Tuesday by the general director of FE-DA, Albert Moles, during the traditional Christmas dinner with the press, where he also recalled that a large part of the energy consumed in the country is imported through signed 10-year contracts given that they have meant a saving of around 60 million. «If last year we had had to buy 100% of the electricity at market price, [to the 20 million losses] it would be necessary to add another 60 million», acknowledged Moles. And if in 2020 the bill for the purchase of energy in neighboring countries rose to 30 million euros, today it is 70 million.

Looking ahead to 2023, the casuistry is expected to improve, not only because of the international situation - with the evolution of the war in Ukraine as the epicenter - but also thanks to all the projects started this year focused on reducing CO2 emissions and the improvement of the transport network and heat networks. Thus, Moles explained that «we have focused on new projects to give us the ability to manage crises like this and more fundamental issues such as the energy transition and rising prices». In short, he pointed out, «projects that help bring

Andorra and FEDA towards a more sustainable and emission-free future [...], expanding wind production plans, electric mobility» or completing the integration of Ctrasa. It is also intended to start the interconnection with Spain, which although it is a decision that depends on the neighboring country, is a «very important guarantee of supply».

However, what is clear is that Andorra is not left out of the geopolitical problems of the environment

and the possibility of supply cuts «is real». In fact, in the months of October and November, Spain was disconnected on up to five occasions (prior notice) to carry out maintenance tasks on its network, which did not affect the customer, since they were compensated by the increase of purchase in France. An extra cost that Moles did not quantify, because it «varies a lot depending on the day and time», but which would have represented a residual amount

in the total expenditure figure. From now on, however, the risk lies in the Gallic country, faced with a sudden increase in demand that cannot be covered in a hypothetical cold wave. In this sense, it should be remembered that France has carried out a drill in case of a major blackout and FEDA is finalizing a contingency plan in this regard. «The possibility [of supply cuts] is there, but management and capacity too. At the end of the month we will finish

defining a plan that does not deal so much with the actions of FEDA but with customers and users, so that it is done in an orderly and equitable way», pointed out the general director. The objective, then, is that regardless of whether the provider is FEDA or a mutual, the impact is distributed equally among all the citizens of all the parishes with divided time slots and with a minimum of 24 hours notice, because above all shops and hotels can be reorganized without affecting the quality of their services. Regarding a new escalation of the electricity bill at the beginning of the year, Moles admitted that «it is difficult to position yourself», because «the part that comes from outside cannot be controlled». However, he assured that he has no «indications» that the situation will worsen, therefore, for now, prices will remain at the latest increase that has just come into force this December. Finally, the director general pointed out that «energy is the basis and competitiveness of the country» and invited both the public and private sectors to «go hand in hand» to address the future «more decisively». \equiv

The PS ends its participation in the political pact due to the negotiations

he Social Democratic Party (PS) has decided to put an end to its participation in the political agreement for negotiations with the European Union (EU) to «effectively defend the interests of the country». This was defended last Tuesday by the president and candidate for head of government in the next elections, Pere López, and the first secretary of the PS, Gerard Alís, assuring that from the formation he was in favor of the association agreement with the EU, but not as it is currently being negotiated by the Govern-

«The negotiation is not going well», asserted López, pointing out that the head of the negotiating delegation «does not have the right profile» and the Ministry of Foreign Affairs has been left out, so the bargaining position is weak. From the PS they also reiterate that they are leaving the agreement because «we have been lied to repeatedly» about the existence or not of different documents and the positions presented by the Member States and the commission. Also, López and Alís reaffirmed that the positions and agreements adopted are not adequately informed until they have already been reached. Ultimately, they insist that the objectives and procedures of the political agreement have not been met and for this reason, «trust has been lost».

Equally, from the PS it is consi-

dered that the necessary pedagogy is not being done, and therefore «reluctance is being generated» among the population, partly due to the lack of transparency. Likewise, the social democrats emphasize the Government's desire to hide information.

For all of this, they consider that the agreement itself is being put at risk, and they value that the referendum vote could have a contrary result if it continues along this line, as defended by López and Alis.

That is why the PS is putting an end to its participation in the political agreement now, as there is still time to reverse the situation and many of the most crucial aspects of the negotiation of the association agreement will be left for later

of the elections, which are scheduled to be held next spring. «We are at the end of the legislature and we may still have time to reverse the circumstances that are leading us to very complicated scenarios», assessed López.

In short, since the formation they ended their participation in the political agreement because by being part of it «we didn't do the country any favors», the negotiation of important aspects has been left for the next legislature - and therefore there is nn't a risk to the negotiation itself- and now it is necessary to be able to explain and do a lot of pedagogy so that, in the face of the next legislature, «internal and external changes in the way of negotiating» occur. **≡**
