## The government confirms that there was «no negligence» in the inmate's death

The Executive has been able to close the report, which does not envisage any sanction for the center's workers

Just a week ago, the death of a 28-year-old Andorran inmate was reported in La Comella prison, who allegedly took his own life. The penitentiary center and the Police have already launched an investigation to be able to clearly determine what reasons would have led to the inmate's death, taking into account the maximum surveillance of the space and its adequacy.

The government spokesperson, Guillem Casal, was questioned about this issue during the press conference after the Council of Ministers. Apart from regretting the incident and offering his condolences to his relatives, Casal revealed that the investigation carried out by the Ministry of Justice and the Interior has not been able to attribute any responsibility to the prison workers: «The investigation report shows that there has been no involvement by the cashiers and, therefore, no indication of negligent activity», indicated the minister.

In addition, the head of Environment also revealed that «it is not true that there had been an attempt at autolysis as stipulated», thus confirming that no protocol failed. Due to this report, which has already been closed as he recalled, it has been shown that «no sanctions will be imposed on anyone involved, nor will responsibilities be cleared in this way». Casal also as-

«The center has the obligation to provide its inmates with the maximum resources or needs they require, depending on what their sentence is» sessed that the regimen that the inmate was following was ordinary and that, for this case, accompaniment and monitoring has been carried out as with all inmates.

Finally, it is worth mentioning that the Government spokesman left a reflection on the case stipulating that «the decisions that are taken must be discerned» and that the penitentiary «has the obligation to provide its inmates with the maximum resources or needs they require», depending on what their sentence is or if they are on parole. •

# E. Leclerc unloads his supplies at Rafelbunyol

A change of course due to difficulties accessing with trailers has designated the final location

Last Wednesday, the convoy of solidarity and humanitarian aid that E. Leclerc Andorra has managed to collect during the five days of collection at different collection points that the hypermarket made available, arrived in Valencia. Among all this solidarity collection, a large amount of nonperishable food stands out, such as cans, pre-cooked food or rice; baby products, such as milk powder, porridge or nappies; animal feed; hygiene products and medicines. An initiative that, in other words, will extend until Christmas with another food and toy collection that will take place next December.

In this sense, the good news, and this is what Gemma Ferré, owner of the firm and founder of the initiative, found out for EL PERIÓDIC, is that despite the difficulties they went through to reach their destination, which was the village of Xiva in a start, this Wednesday the batch of supplies was able to land successfully

health and sports equipment to the Valencian Community to support those affected by the DANA weather phenomenon that hit the region last week. The Government spokesman, Guillem Casal, detailed that, if necessary, the Executive has made available

to the Spanish government the fire brigades, civil protection and police for any type of collaboration, as well as heavy machinery of Road Conservation and Exploitation (COEX). «At the moment, we have not been notified of this need, but we are ready to collaborate», explained the minister.

porta area to deposit the load. In this locality, they faced the same problem, which is why they ended up moving to the municipality of Rafelbunyol, where the unloading could be carried out.

The solution to this logistics problem, likewise, could be found in the ships of areas not affected by the catastrophe, «which have been ceded by the municipalities themselves and which have served to receive the shipments without complications», said the person responsible. Once the shipment was received, these spaces were able to distribute it to all the people affected and damaged by the storm. «The Rafelbunyol City Council has told us that our effort has had its destiny, and, for this reason, we are very proud of the help we have provided», said Ferré for this medium.

Regarding the prospecting of the initiative, Ferré specifies that «since the matter is going on for a long time and all help will continue to be necessary», there will be a second shipment next month which has already been confirmed. On the contrary, whether more trips will be made or not will depend on the circumstances, ensuring that «the hypermarket will continue with the its food collection campaign in the coming weeks and that the shipment in December will serve to all Valencians can have a less bittersweet Christmas».
