COMPLAINT FOR THE APPROPRIATION OF FURNITURE FROM SEIZED APARTMENTS

Alleged leakage and malpractice

The ex-husband of the woman claims that the revelation of the case occurred after filing the complaint



The case originates from a complaint filed by the man against his ex-wife.

The complainant and ex-husband of the woman who allegedly appropriated furniture from seized apartments has expressed his rejection in a digital media outlet that made his case public. The complainant claims to EL PERIÒDIC that the media outlet has distorted his words in a case of alleged malpractice involving his ex-wife and in which he is also immersed in a long family conflict. This situation, which was made public after a formal complaint was filed, has become particularly controversial due to an alleged leak of information after the man had filed a complaint with the police, a fact that the complainant considers serious and that has contributed to the spread of inaccurate data.

The case originates from a complaint filed by the man against his ex-wife, whom he accuses of misappropriating furniture from seized apartments, taking advantage of her professional position. According to the complainant, these situations have taken place in recent years and in one specific case he participated in them, although he claims that at that time he was unaware that the furniture was not purchased. "I was in the Ransol apartment,

in the Ginesta building, because she told me that the furniture was legitimate. When I discovered what she was doing, I told her to stop this practice or I would report her," he says.

This version, he explains, is included in the complaint filed with the Police, but despite having explained this same situation to the media outlet, "it has written things that are not true or that I even said." Specifically, the article claims that he has participated in multiple similar cases, which he categorically denies. "They have published that I participated in four or five robberies, but that is not true. It distorts what I said and calls into question my credibi-

lity," he laments. Faced with this situation, his lawyers are preparing a defamation complaint against the digital medium in question. In addition, the man claims to have contacted the latter to request a correction, but has not received a favorable response. "They told me that nothing could be changed, even though much of what they have published is not correct."

Another key point in this case is the leakage of information related to the complaint. The man claims that he was not the origin of the public dissemination of this information. "I started receiving calls from journalists, but I did not agree to speak to anyone until after I had spoken to my lawyers. I decided to explain the case to them to clarify the facts, but I am clear that it was not I who leaked the complaint. This worries me, because it not only affects my privacy, but goes further," he says.

The conflict, however, is not limited to this complaint for malpractice. The complainant also told to EL PERIÒDIC that he has filed a complaint for assault against his ex-wife, in which he states that "she tried to cut me with a knife", adding that "now it has been admitted and we will see how everything continues". Finally, the man underlines that "my goal was to file a complaint because I am tired. I did not expect all this to take on this media dimension or that it would become a source of disinformation about me", he explains. ●



MEETING OF MUNICIPALITIES

The load studies of Escaldes and the POUPs have been delivered, and are ready

Gili reports that all the corporations have not met again with the College of Architects

ESCALDES-ENGORDANY

The last studies of maximum capacity to be delivered to the Government and relevant to the parish presided over by Rosa Gili have already been delivered. They have done so, however, with a delay of more than a month, since at the beginning of November the main Administration already expected to have them all. The leader of Escaldes-Engordany also reported during the press conference following the meeting of consuls held yesterday at the Espai Caldes that her legal offices "are already at their disposal" in the dispute they are having with the Official College of Architects for the preparation of the Urban Planning Plans (POUP). "We have worked from the corporations as best as possible to have these plans closed and with the utmost diligence, they will soon be able to be presented. I am not aware that the municipalities have met again with the members of the College", Gili stated to the media.

Accompanied at the table by the Consul General of Canillo, Jordi Al-

cobé, and apart from the aforementioned, they each explained the two proposals that they had with the representatives of the other five territories. In this way, the Consul from Escaldes announced that they approved the National Youth Plan presented by the Government just a week ago at the meeting. "We have addressed different tasks that have not been able to specify, however, the National Youth Plan has been the most relevant point on the table and

is already underway for its implementation", he said.

For his part, Alcobé stated that an agreement was also approved to address the operation of a platform called 'Argos', which will allow "to monitor and prevent possible natural risks that affect the Principality. The main agents that move and operate with this tool are the specific Fire, Police and Civil Protection services", stipulated the spokesman, but that the different municipali-

ties "are responsible for acting at a sectoral level and in a coordinated manner".

On this, the consul of Canillo specified that despite being the domain of the AR+I, the section on prevention and environmental study is a "topic that also belongs to each Municipality" and that in a meeting with the Executive, they agreed "what tools each corporation could provide in the absence of a specific protocol that would thus avoid future natural risks and because it is not known who or where to act".

On the other hand, it is convenient to point out that this is a digital platform that is currently in a 'beta' phase and that "it is necessary to put it into operation on the ground to verify and measure its effectiveness". Following a question from the press, Alcobé reported that if a calamity like the one that took place a month ago in Valencia were detected in Andorra, "the protocols for action through Civil Protection would be activated immediately and that with little communication, the entire country would already be alerted". ●
